Renovations to motel to create transitional housing. From beginning of project to the end of 2023 \$20,465 was raised in donations and \$14,399 was spent. More funds will be needed as the progress moves from 5 rooms and a manager's apartment to a total of 16 rooms with the manager's apartment.

Donations are given to meet needs in the community from some of the revenue collected through the thrift store and 100 percent of the restaurant dessert sales. \$2229 was donated in 2023 from the restaurant and \$6800 from the thrift store. Large quantities of material goods are given away at zero cost to people in need as well as donated to other nonprofits and many meals are served at zero cost to those in need.
